## **Memorandum of Understanding (MOU)**

This Memorandum of Understanding (MOU) is made and entered into on the 9th day of September, 2025, between Srikishan Sarda College, Hailakandi, Assam, PIN-788151, and Uttarsuri, Sribhumi, Assam, PIN-788710, for the purpose of collaboration in the areas of academics, seminars, workshops, Internship and publications between the two institutions.

### **OBJECTIVES**

1. To provide guidance and support to faculty members for publishing their research papers in journals and books published by Uttarsuri.
2. To jointly organize seminars, conferences, workshops, and popular talks aimed at developing research activities.

### **IMPLEMENTATION**

- i) Jointly organize conferences and workshops focusing on research methodology and publication issues (including books and journals).
- ii) Jointly organize orientation programs to raise awareness on the interaction between humanity and nature, social and environmental issues, cultural values, constitutional rights and duties, development concerns, and more.
- iii) Jointly publish books and special issues in academic journals.


This MOU shall outline the specific commitments made by each party regarding any program and shall not come into effect until it is documented in writing and executed by duly authorized representatives.

**Mode of Instruction:** Blended (online and offline).



## AMENDMENTS




